

# Privacy Notice – RI.KNEE ROBOTICS

## 1. Introduction

The CORI Surgical System is a platform solution which allows for users to execute a variety of arthroplasty and orthopedic applications, including RI.KNEE ROBOTICS. This Privacy Notice is intended to describe the practices Smith+Nephew (“**S+N**”, “**we**”, “**us**”) follow in relation to RI.KNEE ROBOTICS with respect to the privacy of all individuals whose personal information is processed and stored on the CORI Surgical System as a result of use of RI.KNEE ROBOTICS for indicated clinical procedures.

This Privacy Notice is intended to inform you, as surgeon or other member of the team of health care professionals (HCPs) using RI.KNEE.ROBOTICS in relation to a patient’s treatment, about the collection and use of your and your patient’s personal data in connection with RI.KNEE ROBOTICS products and services. Use of RI.KNEE ROBOTICS will be deemed to be consent by you of the collection, use, processing, and transfer of your personal data as described in this Privacy Notice.

## 2. Who manages RI.KNEE ROBOTICS?

S+N refers to one or more of the Smith+Nephew companies, each of which is a separate legal entity and can act as a data controller in its own right. The entity that is acting as data controller of your personal data from use of RI.KNEE ROBOTICS is Smith & Nephew Asia Pacific Pte Limited.

The personal information you provide in RI.KNEE ROBOTICS is shared by S+N, Inc. with one or more entities of the S+N group of companies (see “Who can access your information” section below).

The RI.KNEE ROBOTICS application is hosted on the CORI Surgical System.

## 3. Why do we need your information?

RI.KNEE ROBOTICS needs your information provided in the application to allow you to manage your account. This information also allows us to evaluate and improve current products and services.

Information provided to the CORI Surgical System as a part of RI.KNEE ROBOTICS also allows us to provide you with support as needed. Information may also be provided back to us in relation to complaints for the purpose of investigation and providing standard product support and services to our customers. We rely on your consent for the processing of your personal data in RI.KNEE ROBOTICS.

## 4. What type of personal information is processed in RI.KNEE ROBOTICS?

RI.KNEE ROBOTICS processes and stores the following personal information categories:

- Name;
- Facility of Use; and
- Healthcare System and/or Customer Name

Data entries of Facility and Healthcare System and/or Customer Name are optional. This information is sourced directly from you and is contained on the CORI Surgical System, unless exported for purposes denoted with S+N’s contract with the Customer.

## 5. Sensitive Personal Information

Sensitive personal information reveals your racial or ethnic origin, political opinions, religious or philosophical beliefs, trade union membership, genetic data, biometric data, data concerning health or data concerning sex life or sexual orientation.

S+N does not intentionally collect any of your sensitive personal information via RI.KNEE ROBOTICS. There is no intention to capture your sensitive personal information. RI.KNEE ROBOTICS does provide you as the user with the ability to capture patient information as a part of the RI.KNEE ROBOTICS procedures. This data entry is optional.

Please note that it is your responsibility as a Health Care Professional to obtain consent when processing Patient personal information via RI.KNEE ROBOTICS.

## 6. Who can access your information?

Your personal information is accessed in RI.KNEE ROBOTICS by the following persons/teams:

- Yourself
- Members of your hospital care team;
- S+N - as part of the hospital care team; and
- S+N - to provide support and improve our services.

The access rights detailed above involves transferring personal information in various jurisdictions in which we operate (S+N office locations are listed at ([www.smith-nephew.com/about-us/where-we-operate/](http://www.smith-nephew.com/about-us/where-we-operate/))). We will only process your personal information in RI.KNEE ROBOTICS on the CORI Surgical System in accordance with applicable law and professional regulations in your jurisdiction. Transfers of personal information within our network are governed by the appropriate legal basis.

## 7. Data retention

In relation to the retention of personal information captured in RI.KNEE ROBOTICS on the CORI Surgical System, data is retained on the local system (CORI Surgical System) unless deleted by a hospital user, or in the event the system is returned for any reason.

Your personal information will be retained in compliance with privacy laws and regulations.

After the end of the data retention period or when the purpose for processing (see question 3 above) is complete, your personal information will be deleted.

## 8. Security

S+N is committed to making sure your personal information is secure. To prevent unauthorized access or disclosure, we have technical and organizational measures to safeguard and secure your personal information. All S+N personnel and third parties we engage to process your personal information, are obliged to respect your data's confidentiality.

## 9. Controlling your personal information

S+N will not transfer your personal information to third parties (other than any external parties referred to in section 6 above) unless we have your permission or are required by law to do so.

You are legally entitled to request access to the personal information we hold about you.

To confirm whether your personal information is processed in RI.KNEE ROBOTICS, or to access your personal information in RI.KNEE ROBOTICS, contact your usual S+N representative or email your request to [privacyenquiries@smith-nephew.com](mailto:privacyenquiries@smith-nephew.com).

## 10. Rectification, erasure, and restriction of processing

You can confirm your personal information is accurate and current. You are legally entitled to request correction of your personal data if it is inaccurate. #### 11. **Complaints**

If you are not satisfied with how we resolved your complaint, you have the right to complain to the Personal Data Protection Commission. You can also refer the matter to a court in Singapore.
